The application is targeting ocean and river shipping. It facilitates the workflow of freight forwarding companies and shippers.

About Shipping application

The Shipping application makes it easy for export managers to manage information about customers' orders, sea line bookings, customs broker instructions, driver instructions for container packages, shipment departure and arrival dates, and team members' responsibilities.

The application also allows export managers to access related information at the click of the mouse about customers, containers, bookings, bills of ladings, invoices, and other pieces of information.

In addition, managers can link to information in other modules in the Shipping application, including detailed invoices, revenues, costs, and contracts.

Containers

According to the information entered, the application allows tracking of exported containers by Master B/L and Home B/L.

Each container acquires its own history, each stage of which contains complete information about the container and can be monitored and analyzed at any period of time.

In addition, the application provides for the accounting of costs for each container and printing invoices for partners.

It is possible to bulk load different data from an Excel files for an easy input of export (outbound) detailed information for large volumes.

To analyze intermodal freight and other data by period, the application provides various reports.
